INTRODUCTION

The purpose of this circular is to provide you with information relating to the resolutions to be proposed at the Annual General Meeting involving (i) the proposed grant of the Issue Mandate and the Repurchase Mandate; and (ii) the re-election of retiring Directors and to give you the notice of the Annual General Meeting.

LETTER FROM THE BOARD

GENERAL MANDATES TO ISSUE AND REPURCHASE SHARES

Issue Mandate

At the Annual General Meeting, an ordinary resolution will be proposed such that the Directors be given an unconditional general mandate to allot, issue and deal with new Shares or underlying shares of the Company or make or grant offers, agreements or options which might require the exercise of such power, of an aggregate nominal amount not exceeding 20% of the total number of Shares in issue as at the date of passing of ordinary resolution in relation to the Issue Mandate.

In addition, a separate ordinary resolution will further be proposed for extending the Issue Mandate authorising the Directors to allot, issue and deal with Shares to the extent of the Shares repurchased pursuant to the Repurchase Mandate (the “**Extended Issue Mandate**”). Details on the Repurchase Mandate are further elaborated below.

As at the Latest Practicable Date, the Company has an aggregate of 503,477,166 Shares in issue. Subject to the passing of the resolution for the approval of the Issue Mandate and on the basis that no further Shares will be issued or repurchased after the Latest Practicable Date and prior to the date of the Annual General Meeting, the Company would be allowed under the Issue Mandate to allot, issue and deal with a maximum of 100,695,433 Shares.

Repurchase Mandate

At the Annual General Meeting, an ordinary resolution will also be proposed such that the Directors be given an unconditional general mandate to repurchase Shares (i.e. the Repurchase Mandate) on the Stock Exchange of an aggregate nominal amount of up to 10% of the total number of Shares in issue as at the date of passing of ordinary resolution in relation to the Repurchase Mandate.

Subject to the passing of the resolution for the approval of the Repurchase Mandate and on the basis that no further Shares will be issued or repurchased after the Latest Practicable Date and prior to the date of the Annual General Meeting, the Company would be allowed under the Repurchase Mandate to repurchase a maximum of 50,347,716 Shares.

The Issue Mandate (including the Extended Issue Mandate) and the Repurchase Mandate, if granted, shall continue to be in force during the period from the date of passing of the resolutions for the approval of the Issue Mandate (including the Extended Issue Mandate) and the Repurchase Mandate up to (i) the conclusion of the next annual general meeting of the Company; (ii) the expiration of the period within which the next annual general meeting of the Company is required by the Articles of Association or any other applicable laws of the Cayman Islands to be held; or (iii) the revocation or variation of the relevant resolutions of the Shareholders by ordinary resolution in general meeting, whichever occurs first.

LETTER FROM THE BOARD

An explanatory statement as required by the Listing Rules in connection with the Repurchase Mandate is set out in Appendix I to this circular. The explanatory statement contains information required under the Listing Rules to be given to the Shareholders to enable them to make an informed decision on whether to vote for or against the resolution approving the Repurchase Mandate.

RE-ELECTION OF RETIRING DIRECTORS

According to Article 84(1), at each annual general meeting one-third of the Directors for the time being, or, if their number is not a multiple of three, then the number nearest to but not less than one-third, shall retire from office by rotation, provided that every Director shall be subject to retirement at an annual general meeting at least once every three years. According to Article 84(2), a retiring Director shall be eligible for re-election. Any Director appointed by the Board pursuant to Article 83(3) shall not be taken into account in determining which particular Directors or the number of Directors who are to retire by rotation.

In accordance with Article 84(1) and 84(2), Mr. Xu Bin, Mr. Zhang Fusheng, Mr. Ng Ying Kit and Mr. Huang Shao Ru shall retire from office by rotation at the Annual General Meeting. Being eligible, they will offer themselves for re-election as executive/independent non-executive Director (as the case may be) at the Annual General Meeting.

Details of the retiring Directors who are proposed to be re-elected at the Annual General Meeting are set out in Appendix II to this circular.

ANNUAL GENERAL MEETING

A notice convening the Annual General Meeting to be held at Suite 3103, Sino Plaza, 255-257 Gloucester Road, Hong Kong on Friday, 23 June 2017 at 11:00 a.m. is set out on pages 15 to 19 of this circular. A form of proxy for use at the Annual General Meeting is enclosed with this circular. Such form of proxy is also published on the websites of the Stock Exchange at www.hkexnews.hk and the Company at www.grandocean65.com.

Whether or not you are able to attend the Annual General Meeting, you are requested to complete the accompanying form of proxy in accordance with the instructions printed thereon and return the same to the branch share registrar and transfer office of the Company in Hong Kong, Tricor Abacus Limited, at Level 22, Hopewell Centre, 183 Queen's Road East, Hong Kong as soon as possible, and in any event not less than 48 hours before the time appointed for the holding of the Annual General Meeting or any adjournment thereof. Completion and return of the form of proxy will not preclude you from attending and voting in person at the Annual General Meeting, or any adjournment thereof, should you so wish.

Voting

Pursuant to Rule 13.39(4) of the Listing Rules, any vote of shareholders at a general meeting must be taken by poll except where the chairman, in good faith, decides to allow a resolution which relates purely to a procedural or administrative matter to be voted on by a show of hands. Accordingly, the resolutions to be considered and, if thought fit, approved at the AGM will be voted by way of a poll by the Shareholders.

LETTER FROM THE BOARD

On a poll, every Shareholder present in person or by proxy or, in the case of a Shareholder being a corporation, by its duly authorised representative, shall have one vote for every fully paid Share of which he/she/it is the holder. A Shareholder entitled to more than one vote needs not use all his/her/its votes or cast all the votes he/she/it uses in the same way.

After the conclusion of the Annual General Meeting, the poll results will be published on the websites of the Stock Exchange at www.hkexnews.hk and of the Company at www.grandocean65.com.

To the best of the Directors' knowledge, information and belief, having made all reasonable enquiries, no Shareholder is required to abstain from voting on any resolutions to be proposed at the Annual General Meeting.

RESPONSIBILITY STATEMENT

This circular, for which the Directors collectively and individually accept full responsibility, includes particulars given in compliance with the Listing Rules for the purpose of giving information with regard to the Company. The Directors, having made all reasonable enquiries, confirm that to the best of their knowledge and belief, the information contained in this circular is accurate and complete in all material respects and not misleading or deceptive, and there are no other matters the omission of which would make any statement herein or this circular misleading.

RECOMMENDATION

The Directors consider that the proposed resolutions set out in the notice of Annual General Meeting are in the best interests of the Company and the Shareholders as a whole. Accordingly, the Directors recommend the Shareholders to vote in favour of the resolutions to be proposed at the Annual General Meeting.

This Appendix serves as an explanatory statement, as required by the Listing Rules, to provide requisite information to you for your consideration of the Repurchase Mandate.

1. EXERCISE OF THE REPURCHASE MANDATE

The Company's authority is restricted to purchases made on the Stock Exchange in accordance with the Listing Rules. As at the Latest Practicable Date, there were in issue 503,477,166 Shares. Subject to the passing of the resolution in respect of Repurchase Mandate and on the assumption that no further Shares will be issued or repurchased after the Latest Practicable Date and prior to the date of the AGM, the Board would be authorised under the Repurchase Mandate to repurchase up to 50,347,716 Shares. Furthermore, the Repurchase Mandate covers purchases made only during the period ending on the earliest of (a) the conclusion of the next annual general meeting of the Company; (b) the expiration of the period within which the next annual general meeting of the Company is required to be held by law or the Articles of Association; and (c) the date upon which such authority is revoked or varied by an ordinary resolution of the Shareholders in a general meeting of the Company.

2. REASONS FOR REPURCHASES

The Directors have no present intention to repurchase any Shares but consider that the mandate will provide the Company the flexibility to make such purchase when appropriate and beneficial to the Company. Such repurchases may, depending on market conditions and funding arrangement at the time, enhance the net assets and/or earnings per Share.

3. FUNDING OF REPURCHASES

The Company is empowered by the Articles of Association to purchase its Shares. In repurchasing Shares, the Company may only apply funds legally available for such purpose in accordance with the Articles of Association and the applicable laws and regulations of the Cayman Islands. The Company may not repurchase Shares for a consideration other than cash or for settlement otherwise than in accordance with the Listing Rules. Under the laws of the Cayman Islands, the Shares so repurchased will be treated as cancelled and the amount of the Company's issued capital shall be diminished accordingly, but the aggregate amount of authorised share capital of the Company will not be reduced.

4. GENERAL

If the Repurchase Mandate were exercised in full, there may be a material adverse effect on the working capital requirements or the gearing levels of the Group as compared with the position disclosed in the audited financial statements of the Company for the year ended 31 December 2016. The Directors will consider the financial conditions of the Company prevailing at the time whenever they consider exercising the Repurchase Mandate and do not propose to exercise the Repurchase Mandate to such extent as would, in the circumstances, have a material adverse effect on the working capital requirements or the gearing levels of the Group at the time of the relevant repurchases unless the Directors determine that such repurchases are, taking into account all relevant factors, in the best interests of the Company.

6. DIRECTORS, THEIR CLOSE ASSOCIATES AND CORE CONNECTED PERSONS

None of the Directors nor, to the best of their knowledge, having made all reasonable enquiries, their close associates, has any present intention, in the event that the Repurchase Mandate is approved by the Shareholders, to sell any Shares to the Company.

No core connected person (as defined in the Listing Rules) of the Company has notified the Company that he has a present intention to sell Shares to the Company or has undertaken not to do so in the event that the Repurchase Mandate is approved by the Shareholders. In accordance with the Listing Rules, the Company is prohibited from knowingly purchase Shares from a core connected person and a core connected person shall not knowingly sell his Shares to the Company.

7. UNDERTAKING OF THE DIRECTORS

The Directors have undertaken to the Stock Exchange that they will exercise the power of the Company to make purchases pursuant to the Repurchase Mandate in accordance with the Listing Rules and the applicable laws of the Cayman Islands and in accordance with the regulations set out in the Articles of Association.

8. TAKEOVERS CODE

If as a result of a share repurchase pursuant to the Repurchase Mandate, the proportionate interest in the voting rights of the Company held by a Shareholder increases, such increase will be treated as an acquisition for the purposes of Rule 32 of the Takeovers Code. Accordingly, a Shareholder or parties acting in concert with such Shareholder could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rules 26 and 32 of the Takeovers Code.

As at the Latest Practicable Date, to the best knowledge, information and belief of the Directors having made all reasonable enquiries, the substantial Shareholders of the Company were as follows:

Note:

131,788,686 Shares are beneficially owned by HK Hang Kei, a company incorporated in the British Virgin Islands with limited liability and is wholly owned by Mr. Xu. By virtue of his 100% shareholding in HK Hang Kei, Mr. Xu is deemed or taken to be interested in, and in duplicate, the 131,788,686 Shares owned by HK Hang Kei.

In the event that the Repurchase Mandate is exercised in full and assuming that there is no change in the number of Shares held by Mr. Xu and HK Hang Kei and there is no other change to the issued share capital of the Company, the aggregate shareholding of Mr. Xu and HK Hang Kei in the Company will be increased to approximately 34.46% of the reduced issued share capital of the Company immediately after the exercise in full of the Repurchase Mandate. The Directors consider that such increase in shareholding would give rise to an obligation to make a mandatory offer under Rule 26 of the Takeovers Code. The Directors do not propose to exercise the Repurchase Mandate to such an extent as would, in the circumstances, give rise to an obligation to make a mandatory offer in accordance with Rule 26 of the Takeovers Code or result in the aggregate number of Shares held by the public Shareholders falling below the prescribed minimum percentage required by the Stock Exchange.

9. REPURCHASE OF SHARES MADE BY THE COMPANY

During the 12 months prior to the Latest Practicable Date, the Company had not repurchased any of its Shares (whether on the Stock Exchange or otherwise).

Details of the Directors who will retire from office at the Annual General Meeting and being eligible, will offer themselves for re-election at the Annual General Meeting, are set out below:

(1) Mr. Xu Bin (“Mr. Xu”) – executive Director

Mr. Xu, aged 51, was appointed an executive director on 10 August 2009 and re-designated as the chairman of the Company in February 2015. Mr. Xu was appointed as a member of each of the remuneration committee and the nomination committee of the Company on 1 March 2016. Mr. Xu pursued his studies at the Faculty of Finance in Jilin University, the PRC and has over 15 years of experience in financial management and extensive experience in corporate operation and management. As the Chairman of the Company, Mr. Xu leads and takes primary responsibility in setting the Company’s growth strategy in the PRC and its continued development direction. He heads strategic initiatives and contributes to the Company’s strategic decision making process. Mr. Xu holds directorships in various subsidiary companies of the Group.

Mr. Xu entered into a service contract with the Company for a term of three years commencing on 1 July 2015 and his service shall continue thereafter on a yearly basis subject to termination by either party with three months’ written notice. Mr. Xu shall be subject to retirement by rotation and re-election at the annual general meetings of the Company pursuant to the Articles of Association at least once every three years. Mr. Xu is entitled to the remuneration of HK\$200,000 per month for his directorship in the Company, which is determined by the Board upon the recommendation of the remuneration committee of the Company by reference to the duties, responsibilities and expected time commitment of Mr. Xu to the Company’s affairs and the prevailing market conditions and is subject to an annual review.

As the Latest Practicable Date, Mr. Xu is beneficially interested in 24,365,629 shares of the Company and is deemed to be interested in 131,788,686 shares of the Company owned by Hong Kong Hang Kei Company Limited, a company incorporated in the British Virgin Islands with limited liability and is wholly owned by Mr. Xu. Mr. Xu holds 4,500,000 share options granted by the Company, which entitle him to subscribe for an aggregate of 4,500,000 Shares (equivalent to approximately 0.89% of the existing issued share capital of the Company).

Save as disclosed above, as the Latest Practicable Date, Mr. Xu (i) does not have any other relationship with any Directors, senior management or substantial Shareholders (as defined in the Listing Rules) or controlling Shareholders (as defined in the Listing Rules) of the Company; (ii) does not hold any directorship in any public companies the securities of which are listed on any securities market in Hong Kong or overseas in the three years preceding the Latest Practicable Date, or any other position with the Company and other members of the Group or possess any other major professional qualifications; and (iii) has no interests or short positions in the Shares or debentures of the Company and its associated corporations which are required to be disclosed pursuant to Part XV of the Securities and Future Ordinance.

Saved as disclosed herein, there is no other information in relation to the re-election of Mr. Xu as an executive Director which is required to be disclosed pursuant to the requirements of Rule 13.51(2) of the Listing Rules and the Board is not aware of any other matters which need to be brought to the attention of the Shareholders.

(2) Mr. Zhang Fusheng (“Mr. Zhang”) – executive Director

Mr. Zhang, aged 44, was appointed an executive Director and the chief executive officer of the Company on 28 June 2013. He holds a master’s degree of Nanyang Executive MBA from Nanyang Technological University in Singapore and has extensive working experience in management and leadership role. Mr. Zhang is responsible for overseeing the operations of the Group and holds directorships in various subsidiary companies of the Group.

Mr. Zhang has entered into a service agreement with the Company for a term of three years commencing on 28 June 2013 and his service shall continue unless terminated by not less than three months’ notice given by either party. Mr. Zhang shall be subject to retirement by rotation and be eligible for re-election at the annual general meeting pursuant to the Articles of Association at least once every three years. Pursuant to the service agreement, Mr. Zhang is entitled to the remuneration of HK\$50,000 per month for his appointment as an executive Director, the chief executive officer and an authorised representative, which is determined by the Board upon the recommendation of the remuneration committee of the Company by reference to his experience and responsibilities in the Group and the prevailing market conditions and is subject to an annual review.

Save as disclosed above, as the Latest Practicable Date, Mr. Zhang (i) does not have any other relationship with any Directors, senior management or substantial Shareholders (as defined in the Listing Rules) or controlling Shareholders (as defined in the Listing Rules) of the Company; (ii) does not hold any directorship in any public companies the securities of which are listed on any securities market in Hong Kong or overseas in the three years preceding the Latest Practicable Date, or any other position with the Company and other members of the Group or possess any other major professional qualifications; and (iii) has no interests or short positions in the Shares or debentures of the Company and its associated corporations which are required to be disclosed pursuant to Part XV of the Securities and Future Ordinance.
